
The **Bioeconomy Initiative** has three topics:

- 3. Role of the bioeconomy in promoting sustainable development.




- Bioeconomy includes various economic activities such as agriculture, forestry, fishing, food, bioenergy, and biotechnology.


# High-Level International Processes can be more than just talk-shops


## 2024 Biofuture Deliverable | Develop an Annual Feedstock Use and Supply Report

- **Clarify** the availability of sustainable biomass feedstocks for diverse applications







- Virtual workshop in Q1 2024 will encourage diverse stakeholders to address the Scope of Work, Mode of Action, Budget, etc.
- CEM SOM session to review 1<sup>st</sup> draft of the proposal
- G20 ETWG meetings will allow for G20 feedback
- Proposal to be shared in June with participating CEM Biofuture Countries for acceptance and launch at CEM15 in September

# 2024 Biofuture Deliverable | Support IEA Mapping of LCA-based Policy

### Challenge

- Obligatory and voluntary markets are using LCA based policies in more and more sectors, but little effort is being made to ensure inter-operability.
- Diverse reporting and operational requirements is creating challenges for Industry

### **Mission**

- The IEA will study how LCA is used by policymakers across the world
- Describe the growing heterogeneity of LCA-based policies and the challenges created for Industry
- First step towards enabling greater inter-operability across jurisdictions


## MISSION


The CEM FFA covers demand from hard-to-abate sectors in Industry and Maritime but is missing Aviation.

There are existing entities that we could partner with to cover SAF demand, such as ICAO, ATAG, SABA or WEF/CST.




